If the verification reveals that the claim of the candidate belonging to Scheduled Caste/Scheduled Tribe /Other backward classes/(not belonging to creamy layer)/Economically Weaker Section is false or educational certificates are not genuine or found unfit on Police Verification, his/her Engagement shall be terminated forthwith without assigning any further reasons and without prejudice to other criminal/legal action as may be taken under the provisions of law/rules.

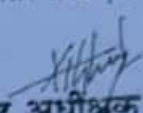
3. The sevak will also have to undergo satisfactory prescribed Training course and Practical Training, as and when the orders to this effect will be issued.

4. Shri/Smt/Ms **SAVITRI BHAIREGOUDA VEERALINGANAGAUDRA** should clearly understand that his/her engagement as GDS shall be in the nature of a contract and is liable to be terminated at any time either by the Sevak to the Engaging Authority, or by the Engaging Authority or any Authority to which the Engaging Authority is subordinate or any other Authority empowered in that behalf by the government, by general or special order, to the sevak, in accordance with the provisions of Rule 8 of the Department of Posts, Gramin Dak Sevaks (Conduct & Engagement) Rules, 2020 [in Short GDS Rules] as amended from time to time.

5. The Sevak should also clearly understand that his/her Conduct and Engagement shall be governed by the GDS Rules, as amended from time to time. As per Rule 3-A(vii) of GDS Rules-2020, failure to reside in place of duty for GDS BPM and in place of delivery

jurisdiction for ABPM/Dak Sevak after engagement shall be treated as violation of conditions of engagement and liable for disciplinary action under Rule-10 of GDS (Conduct and Engagement) Rules, 2020 resulting in removal/dismissal from enagement.

6. If any information or documents submitted by the candidate is found false/incorrect at a later stage, his/her engagement shall be terminated in accordance with the provisions of GDS Rules, 2020, as amended from time to time.
